


ABOUT VANGUARD COLLEGE

- Solid familiarity, loyal connection, and high appreciation for The Pentecostal Assemblies of Canada, its mission and doctrinal perspective plus the proven capability for inter-denominational collaboration



- Track record of local church volunteer ministry history
- Leading the accomplishment of results through mid-sized groups of volunteers and high-capacity vocational Christian leaders
- Reputation for followability and mobilization of teams
- Development and effective administration of significant organizational budgets
- Interpersonal relationships with coworkers and local church vocational leaders
- Christian higher education preferably at a Master's level or equivalent leadership abilities
- The historical record for catalyzing significant ministry plans and successful implementation
- Monitoring team performance relative to achievement of goals/outcomes within executive parameters
- Reputation for continual innovation and improvement in organizations
